History In 2000, Dan Rochon, Marc-André Gagnon, Mélanie Gagnon, and Normand Savoie established Winery Marc-André to produce and market wines from their own vineyards on the Saint-Raymond appellation. In 2005, wine and spirits distributor Joan Charlebois brought the partners together, urging them to produce and sell their own spirits. In 2006, the company became known as St. Lawrence Spirits. The first St. Lawrence Spirits product was Vodka, produced at its Magog Valley distillery. Upon its release, it was marketed under the name of St. Lawrence Craft Spirits. As the company evolved, they began producing and marketing two spirits, a single malt whisky and a line of single-malt Scotch whiskies. Under the direction of Volpe, the company has undergone major growth, with the company now employing about 90 people. In 2011, the company made a decision to add a winery to its facility and in 2013, signed a deal to add a Canadian whiskies distillery. In 2014, the company released the St. Lawrence Rogue Chardonnay, which received recognition as "Best of Category" at the Canadian Beverage Awards.
